Validation Notes for September 5, 2024

General

- 1) The final version of the Accountability Detail Sheets and the At-A-Glance School and District Profiles will be available to preview on **October 3, 2024.**
- 2) The public release of the Accountability Detail Sheets and the At-A-Glance School and District Profiles is scheduled for **Fall**, **2024**. Final date TBA.
- 3) ODE may make minor changes to the language, structure, and format of the reports prior to their publication.
- 4) The refresh schedule for these reports includes the following dates:
 - a. July 25
 - b. August 1, 8, 15, 22, 29
 - c. September 5, 12, 19, 26
 - d. October 3 final refresh

Accountability Detail Sheets

- 1) The Accountability Detail Sheets are embargoed until the public release date. **Please do not duplicate or distribute.**
- 2) The suppressed version of the Accountability Detail Sheets are available to preview as of August 29.
- 3) Starting in 2023-24, the Accountability Detail Sheets will use the **Students Experiencing Poverty** student group definition, replacing the formerly used Economically Disadvantaged Student group. The Students Experiencing Poverty student group includes those students that meet any of the following criteria:
 - a. Received Supplemental Nutrition (SNAP) or Temporary Assistance for Needy Families (TANF) benefits. Data delivered to ODE from the Oregon Department of Human Services (ODHS)
 - b. Were in foster care. Data delivered to ODE from ODHS.
 - c. Experienced houselessness. As defined and reported in the McKinney-Vento data collection.
 - d. Received migrant education services. As reported in the Oregon Migrant Student Information System (OMSIS).
- 4) The data sharing agreement between ODHS and ODE does not allow for ODE to share unsuppressed Students Experiencing Poverty data to district staff. The PDF previews of the Accountability Detail Sheets will suppress Students Experiencing Poverty data when student counts are less than 10 and when rates are less than 5% or greater than 95%.

At-A-Glance School and District Profiles

- 1) The At-A-Glance Profiles are embargoed until the public release date. **Please do not duplicate or distribute.**
- 2) Starting in 2023-24 the At-A-Glance Profiles will report the **Students Experiencing Poverty** student group, replacing the formerly used Economically Disadvantaged Student group. See above for details on what students are included in the new definition.

3) Starting in 2023-24, ODE revised its methodology for measuring College Going to include students in a high school graduating class who enroll in a postsecondary institution <u>before the end</u> of the first academic year following graduation. The denominator for the College Going rate includes students who graduated with a regular or modified diploma in a given academic year, regardless of when they entered high school. In previous years, College Going looked at college enrollment within 16 months of graduation, among students who began high school in the same year. As a result, College Going data in 2023-24 At-A-Glances are not comparable to prior years and prior year trend arrows are not shown.
